THE WORK AT RIM COUNTRY CHURCH-

Our Sunday Bible studies on Daniel are getting challenging as we have gotten into the 10 and 11th chapters. Dan Smyers is doing a good job in his research and teaching these lessons. We were blessed with a visiting neighbor of Brian and Sarah Muller. Brian spoke that morning and the visiting lady seemed to be happy with our service, saying she plans to come back, but she was sick the following week.

Sister Jo Ann Toles is coming regularly even though she has difficulty getting around.

We have re-started sending out flyers to parts of the town that have not yet received them. We pray we will have some good responses.

JOANNE AND DAVE'S HEALTH

I am so glad to report that the acute pain and the shingle pain Joanne has been suffering from has disappeared. She has been able to resume some of her normal activities. It came at a most opportune time.

My health was improving, but I feel embarrassed to relay that I had to go to the hospital again. To get back on the blood thinner, the doctor had me on an increased amount of warfarin. After coming back up to the proper INR level, I had to ask the doctor for the new dosage. My regular doctor was not in so the nurse asked another doctor who said I must stay on the same dosage. I questioned the nurse, but she repeated that I am to stay on the same dosage. So two weeks later I began fainting and having balancing problems. Joanne called 911 and I went to the ER the morning of March 14. My INR had again risen into a dangerous state. Besides the internal bleeding, the doctors also found a hematoma in my right side hip/back muscle that was blocking the nerve to my right leg, making it feel like pins and needles. I was transferred by ambulance to Baywood Hospital in the Phoenix area, some 80 miles away for observation and possible sealing of the internal bleeding vein. They got the bleeding to stop so no procedure was necessary. I was kept in the hospital until the end of March 23 for tests and observation. Brother and sister Muller came to take me home that evening. I was using a walker, but when I used my

weak leg to step onto the porch, my knee buckled beneath me and aggravated the knee and leg problem all over again. I'm gradually getting better, but I'm back using a walker again, still having to nurse my knee and leg. The doctor in the hospital said the results of the hematoma will take a long time to disappear and my leg will still be affected by it for a while.
